INSTRUCTIONS FOR CANDIDATES SITTING THE ADMISSION TEST IN PRESENCE

Requirements for candidates in accordance with art. 3 of the decree law of 23 July 2021 n.105 (which refers to art.9 of the DL of 22 April 2021 n.22 converted into Law n. 87/2021 that governs the “Green Pass COVID-19”) for the admission tests to study courses of the University of Turin at the Lingotto Fiere area.

Access both to outside and inside the premises concerned will be allowed only to subjects wearing FFP2 masks.

In the competition area, **specific dedicated entry and exit routes** are foreseen, clearly identified with appropriate signs, in order to **prevent the risk of interference between incoming and outgoing flows**.

It is foreseen a management of the **candidate's personal items**, which must be placed in a **special envelope**, delivered upon entry, so that there is no contact and contamination between objects belonging to different people and the objects do not come into contact with the assigned staff during the withdrawal and return at the end of the test and in order not to fortuitously exchange objects between candidates to whom they do not belong;

In the **test rooms**, **measures are envisaged for the correct inflow and outflow** on alternating directions, while assigning the post, and during the delivery of the personal data sheet and the answer form, as well as while exiting the premises and for each path that the candidates must do every time they justifiably leave their post;

Candidates must:

- **not come at the place of competition** if they suffer from one or more of the following symptoms:
 - **Temperature above 37.5 ° C** and chills;
 - recently emerged **breathing difficulties**;
 - **sudden loss of smell** (anosmia) or **decreased sense of smell** (hyposmia), **loss of taste** (ageusia) or **altered taste** (dysgeusia)
 - **Sore throat, cough, cold, chills, diarrhea, conjunctivitis, headache** or, in any case, **flu-like symptoms**;
- **not come at the place of competition** if subjected to the **measure of quarantine or fiduciary home isolation** and / or **the prohibition of removal from one's home as a measure to prevent the spread of the COVID-19 contagion**;
- **appear wearing an FFP2 type mask**. This mask must be worn both outside and inside and must be kept for the entire duration of the test, as well as in the event that the candidate has to leave the classroom. Under no circumstances is the use of non-filtering face masks or community masks permitted. In the case of a mask considered unsuitable, the Administration will provide candidates with an FFP2 respiratory protection device;
- **avoid gatherings** and strictly observe the **interpersonal distance of at least 1 meter** both in the **square in front of Lingotto fiere**, while **waiting at the access gates**, and inside the **competition venue** and during all the activities carried out there;
- **enter** the competition area **only one at a time** according to the **instructions of the personnel in charge**;
- frequently **sanitize hands** with the gel contained in the **special dispensers**;
- **appear alone and without** any type of **baggage**, unless there are justified exceptional situations. In this case, candidates will use a **bag** or a **container** in which to **place their baggage**, according to the instructions received from the staff in charge;

- **submit a declaration, pursuant to Italian D.P.R. 445/2000, to certify the absence of any symptom attributable to COVID-19** (according to the declaration form available) and the fact of not being subjected to the measure of quarantine or fiduciary home isolation and / or the ban on removal from one's home as a measure to prevent the spread of the COVID-19 infection. To this end, candidates use the ministerial form, available on the University page or on the University website, dedicated to the procedure;
- **exhibit a COVID-19 green certification (Green pass) issued by the National Platform-DGC (see below how to obtain the green certification)** which certifies one of the following conditions:
 - completed the vaccination course for COVID 19;
 - a first dose or single dose of vaccine has been carried out for at least 15 days;
 - healing from Covid for no more than six months;
 - carrying out a rapid or molecular antigen test with a negative result for the SARSCoV-2 virus with a validity of **forty-eight hours from the execution of the test**;

In the absence of green certification, it is possible to present the relative vaccination certificates or rapid or molecular antigen test certificate with negative results for the SARS-CoV-2 virus, valid for **forty-eight hours from the execution of the test**; the checks (electronic and otherwise) will be noted next to the candidate's name upon entry.

If the **body temperature**, measured on the day of the test, by the candidates themselves (or by the University staff or the organizing body) is **higher than 37.5C °**, the candidate will **not be able to access the competition area** or to declare the contrary in the self-certification and the security staff **must accompany him/her to a special area dedicated to isolation and must promptly notify the competent health authorities**, as well as the police in case of refusal. However, the candidate is required to **immediately inform the commissioners** of the competition and the supervisory staff of **the presence of any flu-like symptoms**, even during the written test, paying attention to remain at an adequate distance (at least two meters) by the people present.

In the event that one or more of the above conditions are not satisfied or in case of refusal to produce the self-declaration, the candidates will not be admitted to the competition area.

THE CANDIDATE IS REQUIRED TO PRESENT THE COMPLETED AND SIGNED "SELF-CERTIFICATION" AND TO SHOW THE GREEN CERTIFICATION FOR VERIFICATION.

If the candidates do **not present a completed self-certification or green paper or electronic certification or it has expired**, they will **not be able to access** and after the identification a brief certificate of **exclusion** will be drawn up.

Identification and entry into the classroom

Candidates, admitted to the competition area, will then be **invited by the assistance staff** to reach the **identification stations**, appropriately **spaced** and according to the **horizontal and vertical signs**. **Pregnant women, candidates with disabilities and candidates requiring additional time** will be **identified with priority**.

Special **hydroalcoholic gel dispensers** will be made available at the **identification stations**. The dedicated staff will invite candidates to **sanitize their hands before and after the identification** and / or **delivery** and / or **receiving the competition material**.

Subsequently, the candidates will be invited to **enter the room** where the **test takes place** and to **occupy a position**, respecting the **distance of at least 1 meter** in all directions, previously determined.

Once the candidates have **reached the position** assigned to them, they must:

- **sit down** for the entire period preceding the test, during and at the end of it until they are authorized to exit;
- **during the exam** hours, you will be allowed to **leave your station exclusively** to go to the **toilets** or for **other undelayable reasons**;
- it is mandatory to **wear the FFP2 mask**;
- scrupulously **follow the instructions provided by the Commissions and supervisory staff**;
- **do not consume food with the exception of drinks** which candidates must already have with them.

INFORMATION ON GREEN CERTIFICATION (so-called GREEN PASS)

How and when the Green Pass can be issued.

The following categories can get it:

- those who received the **first dose of vaccine** (you receive it after **15 days after administration**)
- those who have a **negative test carried out in the previous 48 hours**; - those who have a **vaccination certificate (two doses are needed in Europe)** - those who can prove that they **have been cured of Covid**.

The **Ministry of Health** issues the COVID-19 green certification (so-called green pass) based on the data transmitted by the **Regions and Autonomous Provinces** relating to vaccination, test negativity or recovery from COVID-19. The certification is issued in a printable digital format. You will receive an email or SMS notification or alert that the certificate is ready.

How to get the green pass?

The Certificate can be viewed, downloaded and printed through the following digital platforms:

- via Health Card or digital identity (Spid / Cie)
- Downloading **Applmuni** or **App IO**
- From the website of the **Regional Electronic Health Record, accessing by your SPID**.

For those who do not have digital tools.

Those who do not have digital tools (computers or smartphones) can contact their general practitioner, the pediatrician or the pharmacy for the recovery of their COVID-19 green certification. For a temporary period, the documents certifying the vaccination, the recovery from the infection or the negative result of a molecular or antigen test carried out in the previous 48 hours will have the same validity as the COVID-19 / EU digital COVID certificate.
