Title	Conducting Hybrid Research with Marginalized Groups
Short description by the host university	The Covid-19 pandemic has increased the marginalization that people facing poverty, mental illness, homeless or discrimination are confronted with. At the same time, engaged social and educational research has been forced into relying heavily on remote research methods in order to protect research participants and researchers' health. These research methodologies have brought both new insights, as well as challenges to immersive research processes that qualitative and participatory researchers engage in. This <i>blended intensive program</i> (responding to the Erasmus + Call) is aimed at taking stock of recent developments in hybrid

	<p>and remote research methodologies with marginalized groups and to pass on this knowledge to students. Students will gain a thorough understanding of how to conduct hybrid research with marginalized groups from design to implementation, as well as of the practical and ethical challenges of hybrid research with marginalized groups. Moreover, students will be capacitated in writing-up research results for academic and non-academic audiences. The program entails both virtual and face-to-face training and mentoring activities. Face-to-face activities will be conducted at UVT, in Timișoara, Romania.</p> <p>The program will be structured across four thematic clusters: Digitalization as bridging barriers and/or as an exclusive process that reproduces marginalization / Heritage marginalization and digitalization / Thematic clusters Social justice approaches to data / Data feminism and social justice / Disability, inclusion and digitalization. Each thematic cluster will bring together relevant program faculty teaching the associated modules during the face to face mobility and students that want to design their collaborative or individual research project within the thematic cluster. Thematic clusters should meet for mentoring sessions during the face to face program.</p> <p>The program will contribute to the following outcomes: Learning outcomes:</p> <ul style="list-style-type: none"> • Participants will gain an overview of recent developments in hybrid and remote research methodologies with marginalized groups. • Participants will gain a thorough understanding of how to conduct hybrid research with marginalized groups from design to implementation. • Participants will gain a thorough understanding of the practical and ethical challenges of conducting hybrid research with marginalized groups. • Participants will be capacitated in writing-up research results for academic and non-academic audiences. <p>Program outcomes: The program aims to create a network between students and faculty members of participating institutions that can enable developing both international shared courses and intensive programs, as well as joint research activities.</p>
<p>Proposed schedule by the host university</p>	<p>May 2023: Preparatory online meeting (120 minutes via Zoom): student clusters present their mini-project sketches to other student participants and the BIP program faculty.</p> <p>12th – 16th of June 2023: Physical mobilities to Timișoara happen, 5 days of intensive program activities together (see below).</p>

1st – 15th of July 2023: Students submit final research design and present in a video conference via Zoom to faculty and students.

15th – 22nd of July 2023: Evaluation of student's results based on presentation + research design, awarding 6 ECTS to successful students. Students are encouraged to apply the research designs and work on the results.

Title	The Dynamics between the European Union and the Member States. A comparative (law) perspective
Short description by the host university	The program will be structured on three main topics with a specific focus on their synergy. First will be addressed the specificities of the Member States' legal traditions, with the aim of connecting them to the difficulties experienced on their accession to the EU. Second the participants will be offered a perspective on the main comparative research tools and on their possible output for the social sciences. More specifically, among the variety of methods that have been used throughout time, will be explored the role that comparison may play in the legal field and will be addressed the stakes of interdisciplinarity in the study of law. Third, the participants will be offered examples illustrating the role played in the dynamics between the European Union and the Member States by concepts such as: <i>subsidiarity</i> , <i>consensus</i> , <i>margin of appreciation</i> , <i>constitutional identity</i> ,

	<p><i>autonomous concepts, harmonization.</i> An extensive analysis on the use of comparison in the case law of the CJEU and the ECtHR is also foreseen.</p> <p>The abstract reflection underlying the topic will be accompanied by debates, moot court activities and visits to the local courts.</p> <p>The program aims to create a network between students and faculty members of participating institutions that can enable developing both international shared courses and intensive programs, as well as joint research activities.</p> <p>The program will benefit from the already existing clusters of joint PhD students in the relevant fields developed within the UNITA alliance during its first 3 years of existence who will be actively involved in the program.</p>
