



FACT SHEET FOR PARTNER COUNTRIES INCOMING STUDENTS A.Y. 2021/2022

Version 01 of 27-09-2021

This Fact Sheet is for all incoming exchange students who are planning a mobility period at the University of Turin during the a. y. 2021/2022 and is part of the University's efforts to protect its community's safety and health during international mobility programmes. It also aims to provide instructions for students so that they can be fully aware of the risks that exist during these uncertain times and any inconvenience that may occur.

The information below refers to both general and special standards regarding the COVID-19 pandemic. Therefore, in view of the ever-changing situation, they may be subject to review following further provisions by relevant authorities. MOBILITY 2021/2022 - SPECIAL INDICATIONS FOR COVID-19

Incoming mobility is allowed. Incoming students will be able to attend all classes made available by each degree course, following the same regulations in place for UniTO regular students.

From 1st September 2021, you can access University facilities only if:

- 1. you hold a <u>Green Pass (COVID-19 green certification)¹</u> to show in case of checks
- 2. you can declare:
 - for at least two weeks to have been without any respiratory symptoms, or those of loss of smell or taste and/or a body temperature above 37.5°C, and in suspected or positive cases of SARS-COv2 infection to have complied with the <u>instructions provided by the Ministry of Health</u>
 - **not** to be in quarantine or fiduciary isolation;
 - for the last two weeks and as far as you know, **not** to have been in contact with people who are COVID-19 positive
 - if returning from abroad, to have followed the Piedmont Region Covid instructions
- 3. you wear a surgical mask (or a higher level of protection);
- 4. at the entrance, you trace your presence in the University by scanning the Qr Code posted at the entrance to each facility.

VIRTUAL AND BLENDED MOBILITY

For the academic year 2021/2022 UniTO will offer international students flexible learning resources, addressing both the needs of social distancing in the academic environment and the current uncertainties of international travel. In fact, UniTO allows to carry out a "blended mobility" (both virtual and in presence). If safety conditions do not allow students to leave their home countries at the beginning of the semester, students can start the semester at home and attend Unito's courses online. This way, departure can be postponed and the "physical/presence" will start when conditions will allow it.



Incoming students must verify also with their Home University whether they are eligible for blended mobility.

UniTO guarantees academic recognition of the educational activities whether they are blended and/or virtual, provided they are consistent with the participant's academic path and agreed in the Learning Agreement.



Incoming students must verify also with their Home University whether academic recognition is granted for blended mobility.

The European Commission and INDIRE the National Erasmus Plus Agency, with Note 4/2020 of 19/06/2020 state that only mobility abroad will be financed, so:

- Blended mobility: the participant receives contributions for the actual days of mobility abroad (in Turin in case of incoming students);
- Mobility abroad: the participant receives contributions for the entire period of mobility abroad (in Turin in case of incoming students).

SAFE INTERNATIONAL MOBILITY - STEP BY STEP

The University of Turin welcomes incoming exchange students to become a part of its community. However, given the current situation, bans and restrictions on international travel and local restrictions in response to the COVID-19 pandemic, UniTO allows incoming students to postpone their arrival to the second semester (February 2022 - July 2022), if they wish to defer their mobility period.

BEFORE TRAVELLING TO ITALY

All persons travelling to Italy from any international location are required to fill out the <u>EUROPEAN</u> <u>DIGITAL PASSENGER LOCATOR FORM (dPLF)</u>. Also, as you will travel to Torino, you shall follow the <u>Piedmont Region Covid instructions</u>.

Furthermore, please make sure you understand the following items:

- 1. UniTO recommends participants check whether the following conditions are met:
 - a. national and international health conditions are such that travelling is possible;
 - b. your home country authorities, Italian authorities, the European Commission etc... don't issue any further provision or limitation;
 - c. your Home University authorises international exchanges
- 2. Make sure you check updated information on information on travel conditions to Italy:
 - a. Italian Ministry of Foreign Affairs and International Cooperation portal MAECI:
 - <u>focus: Italian nationals returning to Italy and foreigners in Italy</u>. This page provides useful information about limitations in force to/from certain countries, possible quarantine, restrictions, etc...
 - <u>a page with some Frequently Ask Question (FAQ) about the Government measures issued</u> by the Decree #loRestoaCasa (in different languages)
 - information from Embassies and Consulates
 - b. <u>Re-Open EU Italy</u>

- 3. Follow your home country advice on international travel and restrictions
- 4. Make sure you have a valid document and visa to enter and stay in Italy: <u>https://vistoperitalia.esteri.it/home/en</u>





IMPORTANT - for non-European students

Non-EU students staying in Italy **longer than 90 days** must also apply for a **RESIDENCE PERMIT** (*permesso di soggiorno*) within 8 working days after their arrival in Italy. The comprehensive cost of this document is around 120 euro. - 5. Go to your local health centre to find out about the preventative measures you should take before departure, necessary or recommended vaccinations in order to obtain a clean bill of health certificate. Students should independently consider purchasing insurance cover that guarantees repatriation for medical reasons, reimbursement of medical expenses and typical additional "travel" policy guarantees.
- 6. If you are coming from an EU country, check what is covered by the European Health Insurance Card (EHIC). This card entitles the bearer to free accident and emergency treatment in EU countries. Some benefits may be provided indirectly, i.e. paying costs on the spot and then obtaining a subsequent reimbursement on. Check your National Health Card for the dates you are covered for a stay abroad.



IMPORTANT

The EHIC may not cover repatriation to your country of residence for medical reasons. Students should independently consider purchasing insurance cover that guarantees repatriation for medical reasons, reimbursement of medical expenses and typical additional "travel" policies guarantees. If you take out private insurance, check the conditions related to the COVID-19 health emergency.

- 7. Students with private insurance should contact their insurance company to understand what services are included and so that they can provide the names of doctors and or clinics/hospitals that are affiliated to them.
- Both EU and non-Eu nationals can apply for a health insurance with the Italian National Health System (Sistema Sanitario Nazionale - SSN). For further information please visit <u>Health and insurance UniTO</u> webpage
- **9.** Students are advised to purchase **refundable travel tickets** and inquire in advance about booking university accommodation or renting private accommodation and the possible conditions of returning the deposit in case of delay or cancellation.
- **10.** Save contact references for your country embassy or consulate in Italy. In case of an emergency, record location and phone numbers on your phone, inside your passport and safely online.
- **11.** Add a family or friend's contact to your passport in case of an emergency.
- **12.** Check with your mobile phone provider about coverage when in Italy.

- **13.** Give friends and family your contacts in Italy and travel itinerary.
- **14.** Make sure that you are able to pay using different payment methods.
- **15.** Check your driving license is valid should you need to drive in Italy.
- **16.** Make multiple copies of your passport and travel documents as well as useful contact numbers and save them online.
- **17.** Carry copies of your usual medical prescriptions showing your health conditions.
- **18.** Indicate any allergies on your passport, online or wearable device.

DURING YOUR STAY

- 1. Follow the safety rules very carefully, respecting possible restrictions in force both in University premises and around town. Further information is available on the webpage <u>Coronavirus: updates</u> for UniTo Community
- 2. Should you have an accident, notify your home university immediately, then contact us at <u>infortuni@unito.it</u>, at the International Mobility Office (<u>internationalexchange@unito.it</u>) and your UniTO department.
- 3. Do not leave valuables unattended.
- 4. Give news of yourself regularly to your contacts in your home country
- 5. Check the rules for importing/exporting food and plants.
- 6. In the event of a serious attack, armed insurgency or state of war, you are advised to stay in your home and/or hotel temporarily and try to communicate your position to your home country Diplomatic Representative. Be cautious and keep up to date with the local safety conditions, contacting your home country Embassy if necessary and following the local authorities' advice.





FOCUS UNIVERSITY INSURANCE COVERAGE

Registered incoming students (students with a *"Matricola"* number) are covered by the following policies free of charge:

- the Liability Policy provides insurance for damages as students are civilly liable during their university courses;
- the Accident Guarantee Policy provides appropriate insurance coverage against accidents that students might have during their university activities both on University premises and elsewhere, IF PREVIOUSLY AUTHORIZED, outside the University, both in Italy and abroad. This includes, but is not limited to, facilities, industrial or research laboratories, other Universities offices or Research Institutes etc, where students might be studying, visiting or carrying out experiments, complementary and extra activities, in accordance with policy conditions.

NB Accident policies do not generally cover the equivalent of accidents or occupational diseases, so only fortuitous, direct and external events (injury) are covered. Since this policy has the "occupational diseases" clause, any infection may fall in this area. We are, however, obliged to point out that, since there is no precedent or legal norm in this matter to be contested by those who write the insurers' "defensive" strategy on the subject, such coverage for COVID-19 cases will inevitably be determined by medical-legal issues.
