University Contribution and Fees

❖ How are the tuition fees to be paid for a.y. 2025-2026 composed?

- **ENROLMENT FEE**

The amount of the first instalment to be paid **at the moment of matriculation/enrolment** includes:

- **€ 16.00**: duty stamp
- **€ 140.00**: regional fee for university study right

The first instalment does not change based on ISEE or GDP per capita at PPP, however, there are **exemptions for special cases**. You can consult them in the [Contribution and Tuition Fees Regulation](#).

- **FULL-COMPREHENSIVE CONTRIBUTION**

For all study courses, a full-comprehensive contribution ("contributo onnicomprensivo unico": **COU**) is foreseen to cover the costs of educational, scientific and administrative services.

The amount of the **COU** varies from **€ 0.00 to € 3,040.00** depending on:

- the student's **commitment (full time or part time)**, to be chosen when compiling the career plan;
- the student's **year of enrolment**;
- **merit requirements** stated in art. 3.1 of the [Contribution and Tuition Fees Regulation](#);

- **the financial and assets status of the student**, as determined only by the ISEE Universitario or, for international students, by the ISEE Parificato or the GDP per capita at PPP.

- **ADDITIONAL CONTRIBUTION**

Additional contributions are foreseen only for the study courses listed in art. 2 and 6 [Contribution and Tuition Fees Regulation](#)

❖ What are the main deadlines related to payments for a.y. 2025-2026?

- **FIRST INSTALMENT**

- by **20th October 2025** for enrolment in years subsequent to the first year
- by **20th October 2025** for enrolment in all degree courses and 5-year/6-year postgraduate degree programs without restricted number of places (with free admission) *

- by **16th January 2026** for enrolment in **postgraduate** degree programs **without restricted number** of places (with free admission) *
 - by **16th January 2026** for enrolment **with foreign qualification** in all degree courses and 5-year/6-year postgraduate degree programs **without restricted number of places** (with free admission) *
 - **consult the individual announcements of competition** for enrolment on courses with **restricted number of places** *
- **SECOND INSTALMENT**
 - **28th November 2025** for the majority of students
 - **30th January 2026**, solely for students:
 - enrolled for the first year of **postgraduate degrees** completing the **enrolment after the 3rd November 2025**;
 - with a **foreign qualification who enrol on a first a.y.** of an undergraduate/postgraduate degree/5-year or 6-year postgraduate degrees.
- **THIRD INSTALMENT**
31st March 2026
- **FOURTH INSTALMENT**
29th May 2026

For enrolment in years subsequent to the first year and for the second, third and fourth instalments, payment made after the due dates is charged with the **late payment penalty:**

- **€ 40.00** late tuition fee payments **within 45 days;**
- **€ 80.00** late tuition fee payments **after 45 days.**

* **Late payment is not allowed** for **matriculation** to any Course of Study: in these cases, the payment deadline is to be considered mandatory.

❖ How much is the penalty for late payment of instalments for a.y. 2025-2026?

- **€ 40.00** late tuition fee for payments **within 45 days;**
- **€ 80.00** late tuition fee for payments **after 45 days;**
- **€ 40.00** for each expired instalment, only for those who must pay late more than one instalment of a.y. 2025/2026

❖ What should I do if I do not see the payment notice to pay an instalment?

Whether it is:

- the **first instalment** of years subsequent to the first year

You may have:

- **open debt positions** with the University: contact the **Segreteria degli studenti** (Students Registry Office)
- agreed on an **instalment plan** of past debt: contact the **Sezione Diritto allo Studio** (Tuition Fees Office)

- the **second, third or fourth instalment**

The instalment may not be due based on some forms of **exemption and reduction** applicable.

You can however **contact** the Segreteria Studenti (Students Registry Office) or the Sezione Diritto allo Studio (Tuition Fees Office) **for any check**.

❖ What should I do if an instalment amount is abnormal?

If you have any questions about whether an amount is congruent with your position, contact the **Sezione Diritto allo Studio** (Tuition Fees Office) as soon as possible.

❖ What is the amount of the first instalment for the academic year 2025-2026?

The amount of the first instalment to be paid **at the moment of matriculation/enrolment** includes:

- **€ 16,00**: duty stamp, virtually paid at the moment of enrolment
- **€ 140,00**: regional tax for university study right

The first instalment does not change based on ISEE or GDP per capita at PPP, however, there are exemptions for special cases. You can consult them in the [Contribution and Tuition Fees Regulation](#)

❖ What is the full-comprehensive contribution for A.Y. 2025-2026? How is it calculated?

For all study courses, a full-comprehensive contribution (**COU** – “contributo onnicomprensivo unico”) is foreseen to cover the costs of educational, scientific and administrative services.

The amount of the **COU** varies from **€ 0.00 to € 3,040.00** depending on:

- the student's **commitment (full time or part time)**, to be chosen when compiling the career plan;
- the student's **year of enrolment**;
- **merit requirements** stated in art. 3.1 of the [Contribution and Tuition Fees Regulation](#);

Please note that the COU **does not include the first instalment**.

❖ What career consequences does missing a penalty payment have?

If you have any penalty to be paid, you cannot make any career acts, including:

- registration for the **following academic year**
- registration for **exam dates**
- **registration** of exams already taken
- submission of **graduation application**
- **closing** your career
- printing of **certifications** from MyUnito

Missing full or partial payment of a.y. 2025-2026 contribution does not affect access to graduation sessions for a.y. 2024-2025.

❖ Do late payment penalties have a deadline by which they must be paid?

No, but if you do not pay them before **September** you will incur a **career block** that prevents you from registering for the following a.y. year.

In that case to unblock your a.y. registration you will have to settle the debt and contact your **Student Registry Office**.

❖ I have not complied with my tuition payment. What are the career consequences of debt positions?

If you have open debt positions of any kind (student contribution, late payment penalty, return of international mobility scholarship, honor loans, etc.), you cannot make any career acts, including:

- registration for the **following academic year**
- registration for **exam dates**
- **registration** of exams already taken
- submission of **graduation application**
- **closing** your career
- printing of **certifications** from MyUnito

Missing full or partial payment of a.y. 2025-2026 contribution does not affect access to graduation sessions for a.y. 2024-2025.

❖ Are there any student contribution exemptions for special cases?

Yes, there are exemptions for **specific cases**. You can refer to them in Art. 3 of the [Contribution and Tuition Fees Regulation](#)

❖ How to make payments?

Log in to unito.it > Login > Fees and select your preferred payment method from those available.

According to new Italian regulation, **starting from June 30th, 2020 all payments for Public Administrations** must be made through the **electronic system PagoPA** (art. 65, co. 2, del D.Lgs n. 217/2017 as last modified by D.L. n. 162/2019 - Decreto Milleproroghe).

Payment Service Providers (PSPs), such as banks, postal services, payment institutions, and any other authorized entities, may apply **fees** to payments.

Payments previously issued via Payment Slip (MAV) or through domestic wire transfers in Italy are **no** longer accepted.

However, it is still possible to make payments through international wire transfers.

❖ How can I make a PagoPA payment?

From the list **Elenco Tasse**, click on the **receipt number** that you wish to pay.

You can now choose between **two types of payment**:

- **Stampa Avviso per PagoPA**

A **PDF file** is downloaded with all the codes necessary to pay through several ways, for example:

- home banking (section payments CBILL/PagoPA)
- several apps for payment (e.g., Satispay)
- tobacconist's shop and in general at shops of Mooney, Lottomatica and ITB
- bank offices
- ATM counters

- **Paga online con PagoPA**

You will be **led to the page** to access **the service**. Follow the instructions to make the payment out.

❖ I clicked the button "Paga online con PagoPA" but the payment try was not successful. Is there another opportunity to pay?

Instead of clicking on the button "Paga online con PagoPA" already used, select the other: "Stampa Avviso per PagoPA", and follow the instructions, described in the previous paragraph.

A **PDF file** is downloaded with all the codes necessary to pay through several ways, for example:

- home banking (section payments CBILL/PagoPA)
- several app for payment (es. Satispay)
- tobacconist's shop and in general at shops of Mooney, Lottomatica and ITB
- bank offices
- ATM counters

❖ I have just tried to pay but the payment was not successful. Now the buttons "Paga online con PagoPA" and "Stampa Avviso per PagoPA" are not available. Why?

If a payment procedure is interrupted, the "Paga online con PagoPA" and "Stampa Avviso per PagoPA" might be not available for **30 minutes**. During this period of time, do not attempt the payment again or reload the page, as this may extend the waiting period before the payment buttons become available again.

❖ How do I contact PagoPA support?

You can contact PagoPA support here: pagopa.gov.it/it/assistenza

❖ I clicked the "Stampa Avviso per PagoPA" button but another payment notice that I had previously downloaded opened instead. How can I view the correct payment notice?

Delete or rename the old payment notices in the Downloads of the device that you are using; then, return to the payment you need to pay and click again on "**Stampa Avviso per PagoPA**" ("Print Notice for PagoPA").

❖ I am paying through the home banking, I copied the Codice Avviso (Payment Notice Code) on the payment notice, but it is not recognized. Why?

Please note that the Codice Avviso (Payment Notice Code) must be entered **without spaces** between the digits.

❖ I am paying through home banking, but the required code is labelled differently than in the payment notice. Which code should I use?

Some payment procedures may use different terms, for example:

- "Codice Azienda" o "Codice SIA" = **CBILL code**
- "Beneficiario" = **Tax Code of the Creditor Entity**
- "Codice IUUV" o "Codice Pagamento" = **Payment Notice Code**

❖ Can I make payments by bank transfer?

It is not possible to make student contribution payments by bank transfer directly to the University account, except for transfers from foreign bank accounts.

If you need to make a payment by **international transfer**, contact the **Sezione Diritto allo Studio** (Tuition Fees Office) by ticket.

Contribution reduction and exemption

❖ How to benefit from the exemption/reduction of contributions?

International students

If you are a student

- **resident abroad**, *unless* you are:
 - **registered with AIRE and married to a citizen resident in Italy**or
 - **registered with AIRE and your family members are resident in Italy**or
 - **resident in Italy**, but you do **not meet the independence requirements** pursuant to art. 8 of DPCM 159/2013 **and your family members are resident abroad**

you can **request a reduction** for the full-comprehensive contribution based on **the GDP** per capita at Purchasing Power Parity (PPP) of **the country in which you or your parents are resident**.

Non-international students

If you are a student:

- **resident in Italy** and you meet the independence requirements

or

- **resident in Italy** and you **do not meet the independence requirements**, but **your family members are resident in Italy**

or

- **resident abroad**, registered with **AIRE** and **married to a citizen resident in Italy**

you have to **request an ISEE Universitario** in order to benefit from full-comprehensive contribution reduction.

❖ How to benefit from the reduction based on the ISEE Universitario?

The ISEE Universitario can be requested in two ways:

- through the procedure available online from **INPS website**
- by asking to a **CAF** (Fiscal Assistance Centre)

Processing the ISEE Universitario may take **several weeks**, so we recommend applying early.

In order to pay a contribution calculated according to your economic situation, you must request an **ISEE Universitario**:

- by **23rd November 2025**: in order to get in time the right amount of the full-comprehensive contribution according to your economic situation and not to pay the penalty
- from 23rd November 2025 to **27th February 2026**: by paying a penalty of **150.00 €**.

Your ISEE Universitario must report the following definition: "**Si applica alle prestazioni agevolate per il diritto allo studio universitario in favore di: codice fiscale studente**" (translated: "to be applied to social benefits for the right to academic study in favour of: fiscal code of the student"). The fiscal code of **all the students** of that family for whom it is intended to apply for the reduction must be included.

For the purposes of compliance with the deadlines, the date of **submission of the DSU** (translated: the statement) shown on the ISEE Universitario certificate is considered to be the date of presentation.

The **maximum amount** of the full-comprehensive contribution will be applied:

- if you do **not ask** for ISEE **by 27th February 2026**
- if your ISEE value is **higher than 85,000 €**

The ISEE Universitario is **taken** from the INPS database **automatically** by the University and therefore **does not have to be submitted** to the Sezione Diritto allo Studio (Tuition Fees Office).

The **ISEE Universitario 2026** will **only** be considered **if** you have **not already** applied for ISEE Universitario 2025 by 31st December 2025.

❖ **How can I benefit from the fee exemption/reduction if I am an international student?**

For the purposes of the contribution reduction, international students are considered to be students:

- **resident abroad**, **unless** they are:
 - registered with AIRE and married to a citizen resident in Italy
 - registered with AIRE and their family members are resident in Italy
- **resident in Italy**, but they **do not meet the independence requirements** pursuant to art. 8 of DPCM 159/2013 **and** their **family members are resident abroad**

In these cases, you can apply for a reduction of the full-comprehensive contribution for the a.y. 2025-2026 academic year based on the **GDP** per

capita at Purchasing Power Parity (PPP) of **the country in which you or your parents are resident**.

❖ How much is the contribution value based on GDP per capita PPP for each country?

Please check the table available in **ANNEX A** of the [Contribution and Tuition Fees Regulation](#).

We remind you that the full-comprehensive contribution (COU) **does not** include the **first instalment** of the contribution, which amounts to **€ 156.00** (regional fee + duty stamp).

❖ How much is the contribution based on the GDP per capita at Purchasing Power Parity (PPP) of one's own country of residence or that of the parents?

For those applying for a reduction based on GDP per capita at PPP, the amounts of the **full-comprehensive contribution** (COU) are defined as follows:

- **€ 300.00** for GDP per capita PPP **up to € 26,000.00**
- **€ 500.00** for GDP per capita PPP between **€ 26,000.01 and € 40,000.00**
- **€ 700.00** for GDP per capita PPP between **€ 40,000.00 and € 60,000.00**
- **€ 1,000.00** for GDP per capita PPP **over € 60,000.00**

We remind you that the full-comprehensive contribution (COU) **does not** include the **first instalment** of the contribution, which amounts to **€ 156.00** (regional fee + duty stamp).

The contribution for the entire academic year will be divided as follows:

Instalment	Deadline
First instalment € 156.00	To be paid at the moment of matriculation/enrolment: please consult the relevant deadline in your case

In the case of COU payment based on the GDP per capita at PPP of the country of residence, the value of the GDP per capita PPP of the Country of residence will be used to **determine further contributions** proportional to the student's economic condition: e.g. the amount due for study courses with **additional contributions** Business & Management and Business Administration.

❖ How can I apply for the reduction based on GDP per capita PPP?

If you are an international student, you can ask for the GDP reduction for a.y. 2025-2026:

- **by 23rd November 2025**
- after 23rd November 2025 and **by 27th February 2026** with a penalty of **€ 150.00**

After the deadline of **27th February 2026**, you are not entitled to the reduction/exemption and you are required to pay **the maximum amount**.

The procedures for applying are as follows:

- **If you are resident abroad**

Check within the deadlines that **the country of residence** declared in your unito.it > Login > Personal Data is correct and updated. The University will directly apply the COU based on GDP per capita PPP of the country of residence

- If you are resident in Italy but do not meet the independence requirements and your family members are resident abroad

Apply by the deadlines by filling out the dedicated **Google Form**, available in your unito.it > Login > Career > Fees reduction.

❖ Can I apply for the ISEE Parificato reduction?

For a.y. 2025-2026 in the event that the GDP per capita PPP value does not correspond to your economic situation, you can submit the ISEE Parificato for the purpose of **placement in the GDP per capita PPP band most corresponding** to your economic situation.

In this case the following COU amounts will apply:

- **€ 300.00** for ISEE Parificato **up to € 26,000.00**
- **€ 500.00** for ISEE Parificato between **€ 26,000.01 and € 40,000.00**
- **€ 700.00** for ISEE Parificato between **€ 40,000.00 and € 60,000.00**
- **€ 1,000.00** for ISEE Parificato **over € 60,000.00**

We remind you that the full-comprehensive contribution (COU) **does not** include the **first instalment** of the contribution, which amounts to **€ 156.00** (regional fee + duty stamp).

The ISEE Parificato must be **delivered** by ticket using the **Helpdesk service**, addressing to the Sezione Diritto allo Studio (Tuition fees Office):

- **by 23rd November 2025**
- after 23rd November 2025 and **by 27th February 2026** with a penalty of **150.00 €**

In case the ISEE Parificato is not delivered by the deadline of 27th February 2026, you are not entitled to the reduction/exemption of the full-comprehensive contribution, and you are required to pay the maximum amount.

ISEE Parificato certifications issued **before 1st January 2025** will not be accepted. Therefore, data from such certificates **cannot be confirmed**.

❖ I have enrolled in a postgraduate degree. Do I have any particular deadlines?

If you complete the **enrolment after 3rd November 2025**, no penalty will be charged for request of reduction of the full-comprehensive contribution based on ISEE Universitario / GDP per capita PPP of the country of residence carried out after 23rd November 2025.

However, you must carry out the request of reduction **by 27th February 2026**, otherwise you will pay the maximum amount due.

❖ I have enrolled in a study course with restricted number of places.
Do I have any particular deadlines?

If you are admitted **after 3rd November 2025**, you can carry out the request of **reduction** of the full-comprehensive contribution based on ISEE Universitario / GDP per capita PPP of the country of residence **within 30 days after the admission** without paying any penalty.

❖ What is the NO TAX AREA?

The no tax area is a possibility introduced by the 2017 Stability Law, which provides for **total exemption from the payment of the full-comprehensive contribution** (COU) for students who meet certain requirements.

For a.y. 2025-2026, at Unito, you are in the no tax area if you meet these **requirements**:

- **First year**

- ISEE lower than € 26.000

- **Second year**

- ISEE lower than € 26.000
- **10 CFU** earned between August 11, 2024 and August 10, 2025

- **Following academic years, up to first year beyond nominal length**
- ISEE lower than € 26.000
- **25 CFU** earned between August 11, 2024, and August 10, 2025

Please note that **the first instalment of € 156.00**, consisting of the regional fee and duty stamp, **is still required**.

❖ **What are the merit requirements to qualify for additional exemptions/reductions as provided by the Stability Law 2017?**

The **merit requirements** for the academic year 2025-2026 are as follows:

- **Enrolment in the first year**
No requirements
- **Enrolment in the second year**
10 CFU earned between 11th August 2024 and 10th August 2025
- **Enrolment in the following academic years, up to first year beyond nominal length**
25 CFU earned between 11th August 2024 and 10th August 2025

If you meet the above requirements, the amount of COU will be determined based on the formulas outlined in **Article 3.1** of the [Contribution and Tuition](#)

[Fees Regulation](#). These represent further reductions/exemptions compared to the formulas outlined in Article 2.

Article 2 remains valid **if you do not meet the merit requirements**.

N.B. Credits related to validations (e.g., for career abbreviations due to academic studies abroad and completed in Italy, incoming transfers, or changes of Study Program) **are not counted** towards meeting the merit requirements. However, credits recognized for periods of international mobility, programs for obtaining double degrees, internships, and ECDL are included in the calculation.

In case of change of degree or incoming transfers or carry out a shortened degree program, etc., **only the credits earned during the reference period** are counted, and not the validated ones.

❖ **Are there exemptions based on merit requirements in case of enrolments from the 2nd year beyond nominal length?**

No. For enrolments from the second year beyond nominal length, the COU amount is calculated based on the formulas outlined in **Article 2** of the [Contribution and Tuition Fees Regulation](#), exclusively considering the **ISEE value** and the chosen **commitment** (full-time or part-time).

❖ Do exemptions/reductions apply also if I want to pursue an additional degree?

Yes: Articles 2, 3, and 4 of the [Contribution and Tuition Fees Regulation](#) do not make distinctions regarding enrolment for the achievement of an additional degree.

❖ Do I need to submit the ISEE Universitario to the University?

No. The University gets the ISEE Universitario **directly from the INPS database**. At the time of acquisition, you will receive a notification email on your @edu.unito.it account.

However, acquisition is never automatic in case of **rettifica** (correction), **ISEE Corrente**, or a **new ISEE** submitted to correct the one previously acquired: in these cases, please contact the **Sezione Diritto allo Studio** (Tuition fees Office) via ticket.

You can always **check** the acquired ISEE data at unito.it > [Login](#) > [Career](#) > [Fees reduction](#).

❖ I have applied for a.y. 2025-2026 Edisu scholarship. If I were excluded, could I still access the reduction/exemption of the contribution based on the ISEE?

Yes, you can obtain the exemption or reduction of the contribution by requesting the **ISEE Universitario** / requesting a reduction based on **GDP per capita at PPP within the deadlines** specified in Article 4 of the [Contribution and Tuition Fees Regulation](#).

N.B. It is not possible to apply for tuition fees reduction confirming data from an ISEE Parificato issued before 2025.

❖ I am "idoneo" (eligible) or "vincitore" (winner), for the a.y. 2025-2026 Edisu scholarship. Can I apply for the reduction of the additional contribution, not covered by the scholarship, based on ISEE or GDP per capita PPP?

Yes, for **Business & Management** and **Business Administration** courses, which provide a reduction of the additional contribution based on the economic situation.

In this case, you can obtain the reduction of the additional contribution by requesting the **ISEE Universitario** / requesting a reduction based on **GDP per capita PPP within the deadlines** specified in Art. 4 of the [Contribution and Tuition Fees Regulation](#).

❖ My residence is in a different place from my parents: how does it affect my ISEE Universitario?

Check if you meet **both independence requirements** (Art. 8 of DPCM 159/2013 and Art. 3 of D.M. 1320/2022):

- **residence outside the unit** of the family of origin, for **at least two years** from the date of submission of the ISEE, in accommodation not owned by one of its members
- adequate **income capacity**, that means having produced tax-declared income from employment of no less than **€9,000 per year for at least two years**.

If you **do not** meet one or both conditions, you are part of your parents' family unit for the purpose of obtaining the ISEE Universitario.

❖ What are the requirements to be considered an independent student?

To be considered an independent student, there are **2 requirements** (Art. 8 of DPCM 159/2013 and Art. 3 of D.M. 1320/2022):

- **residence outside the unit** of the family of origin, for **at least two years** from the date of submission of the ISEE, in accommodation not owned by one of its members

- adequate **income capacity**, that means having produced tax-declared income from employment of no less than **€9,000 per year for at least two years**

If you **do not** meet one or both conditions, you are part of your parents' family unit for the purpose of obtaining the ISEE Universitario.

If in doubt, always consult your CAF or professional of choice.

❖ Can I modify/replace an ISEE?

Yes, if:

- the ISEE to be replaced contains errors or discrepancies

In this case, you must request a formal **rettifica** (correction) from the same office (ex. CAF) that issued the original ISEE. Then you have to send the correct ISEE to **Sezione Diritto allo Studio** (Tuition fees Office) via **ticket**.

- you have an ISEE Universitario Corrente

In this case, the ISEE Universitario Corrente must be sent to **Sezione Diritto allo Studio** (Tuition fees Office) via **ticket** before its expiration date.

We remind you that the **ISEE Universitario 2026** is **only** acquired **if you haven't already requested** the ISEE Universitario 2025 by 31st December 2025.

❖ What is Isee Corrente?

ISEE Corrente can be requested by students whose family experiences a **significant reduction of ISEE Universitario**, if the conditions pursuant to art. 9 of the D.P.C.M. 159-2013 apply. ISEE Corrente must refer exclusively to an ISEE Universitario required within the deadlines.

In order for the University to **acquire** the ISEE Corrente, the related ISEE Universitario must have been requested for **by the deadlines** for a.y. 2025-2026.

We remind you that the **ISEE Universitario 2026** is **only** acquired **if you haven't already requested** the ISEE Universitario 2025 by 31st December 2025.

❖ Are ISEE declarations checked by the University?

The University **checks** the ISEE Universitario certifications: it checks the truthfulness of the family situation declared by the students and compares the income and assets data with the information system of the Ministry of Economy and Finance or with the data requested from the consulates.

In the event that the University finds untruthful declarations and this is relevant for the purposes of granting the benefit, an **administrative procedure** is opened to check the truthfulness of the family situation and the income and assets data declared for the eventual imposition of the **sanction** foreseen.

For full details, please refer to Art. 10 of the [Contribution and Tuition Fees Regulation](#).

❖ What happens if the University verifies that my ISEE is not correct?

If the investigations result in the finding of untruthful declarations and said declarations have an impact on the concession of the benefit, the following situations can arise:

If the **gap** between the declared ISEE and the information obtained from the cross-check is:

- **less than € 3,000.00**
 - the investigation will be archived
- **between € 3,000.00 and € 10,000.00**
 - you will have to pay the **supplement** of the comprehensive contribution redetermined following the recalculation of the ISEE Universitario value
 - you will have to pay an **administrative sanction** of **€ 250.00**
- **higher than € 10,000.00**
 - you will **lose** access to the reduction **until the end of your degree;**

- you will be required to pay an administrative **sanction** penalty equal to **three times the difference** between the amount of the full-comprehensive contribution re-calculated based on the ISEE calculation and, potentially, the one paid based on the ISEE used

In accordance with art. 76 of the D.P.R. 445/2000, in the event of false declarations, the University will also notify the **relevant legal authority** in order to investigate whether a crime has been committed.

Reimbursements

❖ What are the main cases in which a refund is possible?

Undue payments contributions are refundable in the following cases:

- application of **exemptions**
- reduction based on **ISEE or GDP per capita PPP**
- graduation in the **previous academic year** (e.g. graduation in extraordinary session)
- graduation with a mark of **110/110 cum laude**, in the first available session, with current enrolment and without having obtained a shortened career
- **double payments**

❖ Are there any payments that Unito does not refund?

The amounts paid for **admission tests** and **duty stamps** are **never refundable**.

The refund of the **regional fee** is [Edisu Piemonte](#)'s competence.

❖ Which refunds must be requested by the student and which are made ex officio?

- Refunds paid ex officio
- **graduation in the previous academic year** (e.g. graduation in extraordinary session)
- obtaining the degree with a mark of **110/110 cum laude**, in the first useful session, with current enrolment and without having obtained a shortened career path
- eligibility or winning an **Edisu scholarship**

→ are processed ex officio, you do not need to make a request.

The timeframe for processing the reimbursement is **90 days** from the end of the degree session or from the communication of data by Edisu, provided that you have entered the **reimbursement method** promptly in MyUniTo.

- Refunds processed on request

For all refunds not listed among those processed ex officio, after entering a **valid refund method in the Personal Data** section of [MyUniTo](#), it is required to contact the **Sezione Diritto allo Studio** (Tuition Fees Office) by ticket or telephone.

The refund will then be processed within 90 days.

❖ How do I enter or change my refund mode?

Please follow the steps below to choose your refund method:

unito.it > [Login](#) > [Enrolments](#) > [Personal Data](#) > [Edit Bank Account Refund Data](#)

You can choose:

- **“bancoposta/CC bancario/carta prepagata”** (bank account/prepaid card) the bank account must be in the name or joint name of the student benefiting from the refund
- **“a mezzo cassa presso il tesoriere”** (by cash at the bank office): you will receive an e-mail on the institutional account @edu.unito.it with the payment mandate and instructions for collecting the money at any bank office of Banca Intesa Sanpaolo
- **“a mezzo assegno circolare non trasferibile”** (by non-transferable bank cheque): the cheque will be sent to the residential address indicated in the MyUniTo Personal Data, at the charge of the student benefiting from the reimbursement

The method of reimbursement will also be considered for any future refunds: check periodically that the data entered in MyUniTo are **correct** and **updated**.

❖ I graduated in the extraordinary graduation session, how do I get a refund of the fees paid in excess?

The reimbursement of the regional tax for the right to university study is the competence of [Edisu Piemonte](#).

Refunds of the **full comprehensive contribution** (2nd, 3rd, 4th instalment) are processed ex officio within 90 days from the end of the extraordinary session, it is not necessary to make a request.

Make sure you have entered a valid refund method in the Personal Data of your [MyUnito](#).

Instalment plans

❖ What is an instalment plan of payments?

An instalment plan allows students to split their payments into agreed instalments.

Compliance with the agreed payment deadlines allows for the regular continuation of the career, including the booking of exam dates and the possibility of renewal of the enrolment. No penalty is charged in the event of late payment.

In any case, all payments must be settled by the time the graduation application is submitted.

❖ When can I request an instalment plan?

You can request an instalment plan of single payments of **€ 500.00** or more, if you have a valid **ISEE Universitario / ISEE Parificato** of **€ 40.000.00 or less**.

The first instalment and the penalties **cannot** be divided into further instalments.

The **additional contribution** can be divided into instalments only upon authorization of the study courses.

Please see also **art. 8** of the [Contribution and Tuition Fees Regulation](#).

❖ How can I ask for an instalment plan?

Contact the **Sezione Diritto allo Studio** (Tuition Fees Office) via ticket.

❖ Can I pay instalments before they are past due?

Yes.

❖ Can I change my instalment plan?

Yes, you can submit a **reasoned request** to the attention of the Supervisor of the **Sezione Diritto allo Studio** (Tuition Fees Office).

The Equity Commission

❖ What are the tasks of the Commissione Equitativa (Equity Commission)?

The Commissione Equitativa (Equity Commission) has the task to:

- assess requests for a fair interpretation of the rules in order to **benefit from the exemption/reduction of the full-comprehensive contribution** or the recognition of the condition of autonomy provided for in art. 8 of the D.P.C.M. 5 December 2013, n. 159
- examine applications for **suspension of studies for serious personal or family reasons**, pursuant to art. 13 of the [Regolamento delle carriere studentesche](#) (Student Career Regulations)
- examine the applications of **students on international mobility** who are experiencing social and/or economic hardship and/or who have faced emergency situations of various kinds.

❖ How to appeal to the Commissione Equitativa (Equity Commission)?

You can appeal to the Commissione Equitativa (Equity Commission) only if you are **enrolled** in an Undergraduate degree, Postgraduate degree, 5-year or 6-year postgraduate degree.

You can submit a request by sending a ticket to the **Sezione Diritto allo Studio** (Tuition fees Office) no later than the seventh day before the date of the Commission's meeting.

Remember:

- make the **request** clear
- detail the **motivation**
- attach **documents** / **evidences** to support what has been declared

After submitting the request you will have to pay **duty stamp** of **€ 16,00**: the notice of payment will be available on unito.it > **Login** > **Payments**.
