List of exemptions from the online application procedure on Apply@Unito for the academic year 2022-2023

(v02, 31-05-2022)

❖ You are exempt from applying via [Apply@Unito](#) for the academic year 2022-2023 if:

- You hold a foreign study qualification and you will enrol at UniTo within the framework of a mobility project aiming at obtaining a double degree;
- You hold a foreign study qualification and you want to transfer from another Italian University or to change program within the University (follow the instructions available at the following page [link](#));
- You hold a foreign study qualification and you were previously enrolled in an Italian university (with the career regularly closed) for a degree program of the same educational level; in this case your foreign qualification has already been evaluated for the first enrollment, thus you should follow the instruction at the bottom of the page¹;
- You hold an ecclesiastical undergraduate degree (Baccalaureate), issued by the *Facoltà di Scienze dell'Educazione dell'Università Pontificia Salesiana* through the *Istituto Universitario Salesiano Torino Rebaudengo (IUSTO)*, and are interested in applying for a postgraduate degree. You have to follow the standard procedure for candidates holding an Italian academic degree and have to submit the certified degree ("vidimato") at the enrolment stage;
- You hold an International Baccalaureate (IB) Diploma awarded after 12 years of overall schooling and issued by an educational institution listed in the attachment 2 of the Ministerial regulations regarding the admission of international students published yearly on <https://www.studiare-in-italia.it/studentistranieri/>;
- You hold a foreign study qualification and you have already been enrolled in single courses belonging to a degree program of the same level at the University of Turin, as your foreign qualification has already been evaluated for the first enrollment (follow the instruction at the bottom of the page);

¹ - **for enrolling in an undergraduate and 5 year or 6 year postgraduate degree:** you will be required to upload within the enrolment procedure a self-declaration stating the program, year of enrolment and university where you were previously enrolled; (you are aware of the criminal and administrative consequences when false declarations are given (art. 75 and art. 76 of the D.P.R. n. 445, 28.12.2000), as foreseen by the art. 46 and art. 47 of the D.P.R. n. 445 del 28.12.2000.)

- **for enrolling in a postgraduate degree:** you will be required to submit all the [required documents](#) by email to internationalstudents@unito.it, selecting a maximum of 2 programs you intend to apply for, within May 20, 2022, for the first application period or within September 23, 2022, for the second application period, and attaching a self-declaration stating the program, year of enrolment and university where you were previously enrolled; (you are aware of the criminal and administrative consequences when false declarations are given (art. 75 and art. 76 of the D.P.R. n. 445, 28.12.2000), as foreseen by the art. 46 and art. 47 of the D.P.R. n. 445 del 28.12.2000.)
