## Further information on examinations

Knowledge of a foreign language among: English, French or German, is required.

Master Thesis Abstract to be uploaded within the online platform, min. 15.000 - max 20.000 characters including spaces and bibliography.

Research project (max 30.000 characters, bibliography included) carried out by the candidate choosing a title among those offered by the PhD programme. The examining board will evaluate the scientific dimension of the project, its feasibility related to the length of the PhD, the time plan, the target setting, the scientific impact of outcomes.

Letter of references: the referee must specify the level of knowledge and the scientific capability of the candidate. Letters of reference will not be assessed.

The interview will cover the presentation of the research project: the candidate will explain the subject of the research, the research plan over the three years, the target setting, the expected outcomes.

The interview, on request of the candidate and duly authorised by the examining board, may be taken via Skype (Art. 8 of the Call).
