GUIDE FOR REGISTRATION AND ACCREDITATION AT UNIVERSITY PORTAL UNITO.IT

1. Registration at the portal

In order to register a firm at the University portal it is necessary the previous registration of a representative as individual.

To register an individual at the University portal it is necessary to have an active and functioning e-mail address.

To register, please access the address http://www.unito.it/registrazione and insert the requested data, following the instructions and selecting "Prospecting company" at the item Profile.

During this phase, it is requested to choose a password and to confirm it. This password must be kept, because it is crucial to access the portal, when the registration procedure is completed.

After inserting the data, the system sends a first e-mail with the confirmation request for the registration: the confirmation must take place within 1 hour from receiving the e-mail, by clicking on the indicated link. If you do not confirm within the foreseen time, you need to do a new registration.

With this username and password, chosen after the registration, the user can access the University portal by selecting the item "Login-MyUniTo" in the home page or clicking directly on the link http://www.unito.it/login. In the page "Istruzioni per la registrazione" (Home > Istruzioni e supporto) a tutorial is available, describing the steps to be followed in order to complete the registration.



2. Request for the registration of a firm

Once logged at the portal, from the page MyUnito, it is necessary to associate the firm with an individual already registered at the portal, clicking on "Registration".



Afterwards, in the following page, click on the button "Register a Company"





Now, you can go on with the compiling of the requested data (fields with asterisk are compulsory). Along with the registration form, it is required to enclose a file with the image of the representative. Please, make sure you have all the data, before compiling the form.

Foreign firms which are going to register to the portal, but which cannot enclose the document of the legal representative while compiling the form, will insert the data of the legal representative and will be able to insert a copy of the identity document of the person belonging to the firm, authorized to work with this University.

It is paramount to fill in the form in all parts paying attention, in particular to:

NB The dimension and the name of the enclosure. Do not enclose files too heavy or with too long names and with signs such as apostrophes and stress.

NB1 The field "Enrolment at" is referred to the number issued after the registration to the Chamber of Commerce: it is a compulsory field, but if you do not have this codex, if your category is exempted from this registration, you need to fill in the field by indicating a null value, for example 00 specifying in the notes the reason why you are exempted from the registration to the Chamber of Commerce.

NB2 The field "Web Site" is not compulsory, but if you insert it the system needs a complete address like this: *http://www.website.com*; inserting this way *www.website.com* will be considered an error – the message will be "Format not valid"– and the sending of the module will not be completed.

A registration can have different status: awaiting, registered, rejected, or cancelled.

After the due controls and after the approval of the registration by Unito, the user usually receives a confirmation e-mail within 2 working days from the registration, apart from possible problems on controls in the commercial registers. From this moment on, the user will be able to use the services for the firms, after authentication with the credentials.

3. FAQ

- How can I replace the individual related to the firm?

The firm must register the new person at the portal and communicate the new username and the old username to be cancelled to supporto.imprese@unito.it . The e-mail must come from the old reference person and you must put in cc the e-mail address of the firm or use the e-mail of the firm.

Supporto.imprese@unito.it will inform the firm and the new person of the completed modification.

- How can I modify the legal representative, the address of the corporate domicile or the company title of the firm?

The person, who registered the firm, must send an e-mail to supporto.imprese@unito.it (in cc the firm or the address firm declared in the form of the registered firm – corporate domicile) specifying the new data.

- If I have problems on accessing the account, who can I contact?

You can contact the toll-free number 800 098590 active from Monday to Friday from 8.00 a.m. to 8.00 p.m. and Sunday from 8.00 a.m. to 1.00 p.m. You can also fill in the form.

- If I have problems, linked with the convention, training organization, etc who can I contact?
