	2. certified copy of the foreign degree, provided with certified translation into Italian or English, legalization (if required), and one of the following documents: a. declaration of equal value ("dichiarazione di valore") issued by the competent Italian Embassy/Consulate in the country where the foreign degree was obtained or b. statement of comparability issued by ENIC-NARIC centres: http://www.cimea.it/en/index.aspx ; www.enic-naric.net/country-pages.sepx If you apply for the recognition of a postgraduate degree, a certified copy of the postgraduate degree, the declaration of equal value ("dichiarazione di valore") or the statement of comparability issued by Enic-Naric centres have to be included in the application.
	3. certified copy of the degree programme transcript of records issued by the foreign Institution/University, including marks and ECTS assigned to each exam, provided with certified translation into Italian and legalization (if required). The translation into Italian is not required if the original document is issued in English, French or Spanish. or certified copy of the Diploma Supplement, provided with legalization (if required). If you apply for the recognition of a postgraduate degree, a certified copy of the postgraduate degree transcript of records has to be included in the application.
	4. Degree programme syllabus issued by the foreign Institution/University, provided with translation into Italian. The translation into Italian is not required if the original document is issued in English, French or Spanish. If you apply for the recognition of a postgraduate degree, a certified copy of the postgraduate degree syllabus has to be included in the application.
	5. A photocopy of all the above listed documents.
	6. If you apply for the recognition of a postgraduate degree and the postgraduate degree programme you attended abroad included a final thesis, a copy of your degree thesis, either in paper or electronic format, has to be added to the application. This document is not necessary if you apply for the recognition of an undergraduate degree.
	7. A photocopy of your ID card, Italian fiscal code ("codice fiscale").
	8. 1 stamp duty (€ 16).
	9. Payment receipt of the € 60 fixed fee.

The University reserves the right, at its sole discretion, to request further documents if necessary for evaluating the applicant's educational background.
