COURSE SUMMARY

During the Muslim holy month of Ramadan, families gather to break the fast at sunset and consume a lot of television drama well into the night. Ramadan thus becomes the high season of television in the region, and the themes addressed in the month-long series come to dominate the public debate. Through the lens of Egyptian Ramadan drama, students will engage with representations of law enforcement and its relationship with citizens, as well as the imbrications of state law and confessional law in the regulation of family life, with special attention to relationships between spouses, parents and children, and on the status of minors.
